Minutes

Litany and Opening Hymn "Sanctuary". Pastor John led the reading of the Litany. Larry Lippke led members in singing "Sanctuary."

- 2. Call to Order. President Steve Searcy called the meeting to order at 11:00.
- 3. Adoption of the Agenda. Melinda Grant moved to accept the agenda. Herb Fisher seconded the motion. The motion passed.
- 4. **Approval of Minutes** of the November 14, 2021, annual meeting. Michael Olsen made a motion to accept the minutes. Stuart Anderson seconded the motion. The motion passed.
- 5. President and Committee Reports. The reports are included in the packet. Steve Searcy commented that each committee was asked to include in their report an estimate of hours that volunteers worked throughout the year. Steve thanked everyone for the nearly 5,000 total hours volunteered. He pointed out that this is one phase of stewardship the giving of time, talent, and treasure that allows for Peace Lutheran Church to function.
- 6. Membership Changes. As seen on page 18 of the packet, there has been a slight increase in membership since November 2021. Steve Searcy pointed out that the Council continues to work with the list of perceived inactive members both by phone calls and letters. The Church constitution has three provisions for active membership receive Holy Communion, contribute to the congregational treasury, and/or participate in worship of the congregation. If after two years of not participating, the member is contacted. It is possible that membership could go down as the Council continues to contact people. Linda Snyder asked if there is a way to track virtual participation. The answer is no, virtual participation is not tracked. Steve did respond that the letter asks the recipient to let us know if they are attending services virtually. If so, they will be considered as participating and remain on the roster of active members.
- 7. Treasurer's Report. Larry Lippke provided updated financial statements dated October 31, 2022.
 - a. The <u>Balance Sheet</u> shows that Total Checking/Savings is \$179,998.19.
 - b. <u>Budget vs. Actual</u> shows that through 83% of the year (January-October), General Giving is 70.8% of what was budgeted for the year, and total expenses are 78.7% of what was budgeted. There is a net loss of -\$29,344.65 at the end of October (in the General Giving Fund only). The letter that was sent in early September has been beneficial. Larry thanked everyone for the increase in giving. Without the increase in giving, Larry predicts that the deficit would have been -\$36,000.00 rather than -\$29,344.65 at the end of October. Larry responded that end-of-year giving in years past usually increased; however, after the change in tax laws to

increase the amount of the standard deduction, that increase has not been occurring in recent years.

- c. From the <u>Fund Balance Report</u>, Larry explained that the Insurance Funds of \$40,820.66 is unspent money from the recent water damage in the Fellowship Hall. The Meditation Garden total of \$3,450.00 is from money given in 2014. The Specified Funds of \$959.43 is from the free-will offering at the Oktoberfest gathering.
- 8. **Financial Secretary's Report**. Sandra Gossett provided an updated report through October 2022. Total giving was \$337,923.66 for the year. Sandra thanked the congregation for their gifts and thanked them for using the Vanco on-line giving portal. She also encouraged the congregation to follow Facebook, Instagram, and the webpage.
- 9. Update from the Call Committee. Laura Bay-Williams recognized members of the Call Committee. Laura said many churches are looking for pastors; there are four churches for every pastor available. A form is available in the narthex if anyone wants to nominate a pastor. The nomination form should go to the Call Committee; there cannot be any contact with the person being nominated. Laura thanked the congregation for the one hundred responses to the survey; the Ministry Site Profile was completed in large part from those 100 responses. Pastor Tracey Shultz, from the Gulf Coast Synod, is overseeing the call process and is using that profile in discerning the right pastor for Peace. The Call Committee will be participating in a mock interview in preparation for the upcoming interviews. Laura indicated the committee does not expect to receive candidate names before January. There will be only one candidate presented to the congregation to vote on during a called Congregational meeting. A two-thirds majority ballot vote of members present is required to call the pastor.

10. New Business:

By-laws Amendment. An amendment to the By-laws was proposed by the congregational council, Part V – Officers and Committees. A lengthy discussion of the proposed amendment took place.

The by-laws amendment presented is:

- 1. Eligibility and duties of officers.
 - a. Voting members of the congregation shall be eligible for election as officers except for the following:
 - 1. members of household of the called pastor(s)
 - 2. members of household of full or part time church staff
- 2. Membership and meetings of the Committees
 - a. Voting members of the congregation shall be eligible for election as Committee Chair and Chair-elect except for the following.
 - 1. members of household of the called pastor(s)
 - 2. members of household of full or part-time church staff

Melinda Grant made a motion to amend the proposed amendment by removing the line 2.a.2. Linda Drehs seconded. This amendment to the proposed amendment was defeated by a vote of 12 yes, 46 no.

A vote was then taken on the original amendment as stated above. The original proposed amendment passed by a vote of 54 yes, 3 no.

- **Discussion and Adoption of 2023 Budget**. Larry Lippke presented the 2023 budget and indicated that the Council proposed a budget that had a negative balance, reflecting the current trend in giving.
 - 1. He pointed out that each committee determined the totals for each respective committee total.
 - 2. A new line item, "A.9.1. Online Subscriptions," represents the expenses for online services, i.e., QuickBooks, Church360, Office 365, and Ministry Scheduler Pro.
 - 3. In the "Pastor" budget listing, some assumptions were made. In 2023, it is assumed that Pastor John will be the pastor for six months and the new pastor for the remaining six months. Furthermore, the "Defined compensation" totals assume the new pastor has 15 years' experience, a spouse, and children.
 - 4. The staff was given a 2% raise.
 - 5. Todd Huebner asked about the potential to reduce service and bank fees. Larry described efforts to encourage giving methods that minimize those fees. Givers are encouraged to set up their account using a draft on their bank account (an Automated Clearing House, or ACH, transfer) rather than using a credit card, where a usage fee is charged.
 - 6. Larry further pointed out that if General Giving remains at the six highest months of giving in 2022 (an average of \$36,000.00 per month), the budget will be met.
 - 7. The proposed budget passed unanimously.

• Election of 2023 Congregation Council.

Steve Searcy thanked the Nominating Committee for a job well done. Nominations from the floor were taken for the Chair-Elect of the Congregational Life Committee. Natalie Wright volunteered. The slate of candidates is:

Larry Lippke thanked Steve Searcy for his leadership as President and the congregation heartily agreed. Natalie Wright thanked Larry Lippke for his role as Treasurer for the past three years and thanked Sandra Gossett for her continued role as Financial Secretary.

Steve Searcy thanked the Council and the staff for their work this past year. He thanked all those who have helped to prepare for the new pastor.

11. Adjournment & Closing Hymn "Doxology."

The meeting was adjourned at 12:30. Larry Lippke led the congregation in singing the "Doxology."

PRESIDENT'S REPORT

Members of Peace Lutheran Church,

When I look at the ministries reflected in the "Tidings of Peace," I am always impressed and encouraged by the variety of ministries we have here at Peace. Our church does so many different things to convey the message of God to our church members as well as the community we live in here in Bryan/College Station. I appreciate everyone's efforts, including all volunteers, lay leaders and staff that I have worked with over this past year. Thank you. It has been a privilege and honor to serve as your President.

This year continues to be a challenge for our Call Committee. The market for full time Pastors has increased significantly without a corresponding increase in the number of available pastors, especially with the experience we are looking for in a new pastor. As a result, the opportunities presented to the Call Committee from the Synod have been minimal. We need to continue to stand behind the Call Committee, pray for them, and keep the faith that God will provide the right pastor for Peace.

We have also monitored our giving and expenditures very closely. While giving remained consistent throughout the first eight months of the year, giving seems to have slowed down in September and the beginning of October. All committees have been diligent in watching their expenditures in relation to their budgets. The Executive Committee asked each committee to submit a tight but realistic budget for 2024. The net result when developing a 2024 budget is a projected deficit for 2024. This budget will be reviewed in light of a potential deficit and appropriate adjustments will be considered.

The Executive Committee did address the Reconciling-in-Christ (RIC) initiative from the Texas-Louisiana Gulf Coast Synod. Our decision was not to pursue this initiative. This decision was based in part on a survey of congregational members and other input from the congregation. We believe our church is very inclusive and supportive of all people in our community.

Pastor John continues to provide outstanding spiritual leadership of our congregation as Interim Pastor. We continue to be blessed by all his efforts including but not limited to Sunday Worship, Tuesday Adult Bible Study, and his Animal Village children's sermons. The musical aspects of our services are wonderful, and we are thankful for Kearby Etheredge, Music Director, and Roger Boening, Organist/Pianist for their excellent contribution in this area. We are also thankful for the computer and camera operators that provide the visual components of our service as well as extending the service to those unable to join us in the sanctuary. We are thankful for the efforts of Angela Fleeger and Rhonda Raphael for their work in the Education, Youth and Family, and Congregational Life areas, respectively. Finally, many thanks to Lisa Rives who provides the administrative support that keeps our congregation operating efficiently.

I believe we have a very positive future ahead of us. We are well positioned for our next permanent Pastor. We have an engaging and faith-affirming worship and many effective ministries all of which support our mission statement – celebrating, learning, and serving.

ENDOWMENT COMMITTEE 2023 ANNUAL REPORT

The Endowment Committee is an ad hoc committee of the congregation whose purpose is to oversee the congregation's Endowment Fund, which was established with a balance of \$150,000 in 2005. The fund exists solely for charitable purposes, with the principal objective being the promotion and development of religious, charitable, and educational activities and for non-recurring purposes not regularly budgeted by the congregation. It is a special designated fund and does not appear on Peace Lutheran's Balance Sheet.

Financial Status

The fund is managed by Thrivent Charitable Impact & Investing. As of October 9, 2023, the account balance was \$233,168.77. The end of the year balance for 2022 was 228,915.91 and for 2021 was \$236,221.39.

History of Grants

The Endowment Committee is charged with maintaining and expanding the principal of the fund and annually determines the amount of funds made available to award grants evaluated by the committee and approved by our Congregational Council.

Since 2006, sixty-six grants totaling over \$92,479 have been awarded for needs at Peace not budgeted by the congregation as well as to organizations such as Treehouse, Family Promise, Habitat for Humanity, Hospice Brazos Valley, Central Texas Orphan Mission Alliance, Scotty's House and BCS Prenatal Clinic.

Three grants with a total value of \$2,979 were awarded in 2023. A table detailing these grants is attached at the end of this report.

Endowment Committee Membership

As established by the by-laws of the Endowment Committee, the committee consists of five members who serve 2-year terms with a maximum of 3 consecutive terms. The Treasurer of the church is a non-voting member. The 2023 committee members are Craig Borchardt, Arty Brieden, Philip Gates (Chair), Eric Johnson, Robbie Sells (Treasurer).

Grant Request 1: Habitat ReStore Elevator Repair Endowment Report

Endowment Committee,

On behalf of the Habitat ReStore staff, I would like to thank you for your generous grant of \$2,000 to repair the hoist on the freight elevator at the Habitat for Humanity ReStore. Without the use of the elevator, the staff was not able to take large items like furniture to the second floor and it was greatly reducing their sales and storage space in the building. Your grant allowed them to get the elevator repaired without having to use other Habitat non-restricted funds which are in critical need at the moment. Unrestricted funds are funds donated to Habitat that are not designated specifically for home building. With two new subdivisions planned that will require infrastructure construction that is built with unrestricted funds, these funds are extremely critical. Your donation allowed \$2,000 to be used for these other construction needs. It cannot be expressed how appreciative the Habitat staff are with your generous donation. Below is a receipt for the elevator hoist which ended up costing \$2,339.10 (including a generous discount by Home Depot). The installation labor was done by Habitat construction personnel. Below are some pics of the elevator and the staircase that restricts any other way to get large things upstairs without the elevator. BUILDING & GROUNDS COMMITTEE

Building on the work of my predecessor Jere mills, we have assembled and updated our volunteer panel of experts responsible for various areas of concern and upkeep. We meet regularly, on a monthly or bimonthly basis, normally on the first Thursday of the month.

Although Jere officially rotated off the committee, he continued to organize our lawn crews under the four leaders: Larry Lippke, Connie Flickinger, Bob Gibbons, and Jere himself. Throughout the year, Rhonda Raphael has coordinated the maintenance of flower beds.

For the Texas A&M Big Event, we received fewer Aggies than the twenty we requested, but still managed to get all the outside windows washed, the pews polished, flower beds mulched, and trees trimmed, thanks in part to the good turnout from our own members.

Our previous ZTR John Deere mower was showing its age, and we traded it in on a new one from United Ag & Turf. The cost was \$3,999 with our trade-in. We were able to purchase the mower with a generous member donation of \$2,000 and leftover money from our water damage claims. Thank you to the member for this donation.

Under Joe Young's supervision, the parking lot lights have been replaced and upgraded to LED. Water leaks in the steeple and near the cry room were repaired by Millsap waterproofing, as arranged by Bob Gibbons and Herb Fisher. Bob Gibbons also replaced all AC filters.

In April, with Eric Johnson took the lead, and we painted parts of the church office.

Our committee coordinated with David Reynolds on his Eagle Scout project, to build a fence along Rio Grande Blvd. to prevent Gaga ball players and playground kids from running into the street. This has been completed.

Under Bob Gibbons' leadership, we explored the need for new outside glass doors and contracted to have those in the Narthex, Hallway side door, and Coffee Nook doors replaced. He investigated the possibility of replacing the sliding doors between the offices and the learning center. The latter was deferred because of cost.

Also at Bob Gibbons' suggestion, we have established a priority "wish list" for additional repair and improvement projects, as funding permits.

None of these accomplishments would have been possible without the volunteer help of these and many other members of Peace, in particular my chair-elect, Herb Fisher. I regret that I cannot thank all of them by name.

To address these challenges in the future, we need to be committed to establishing a more efficient process for gathering event information from sponsors and emphasizing the importance of adhering to deadlines, ensuring that our website remains a valuable and up-to-date resource for all stakeholders.

Another notable challenge faced by the Communication Committee this year was creating multiple versions of a graphic to suit various media formats. This posed a considerable challenge regarding time and resource allocation, as each media channel required a distinct graphic version to ensure it was displayed correctly and effectively. This situation increased the workload and complexity for the office manager, impacting efficiency and consistency in our visual communications efforts. Moving forward, there should be an effort to streamline this process, possibly by investing in tools or strategies to facilitate more efficient graphic adaptation for diverse media formats, thus improving our communication effectiveness.

Future Plans and Goals

Moving forward, the future goals for the committee should be aimed at elevating our communication strategies and community engagement to new heights. First and foremost, the committee should pursue better integration with social media platforms, ensuring seamless sharing and synchronization between our website and platforms like Facebook, Instagram, and Twitter. This will help extend the reach and engage with a broader audience, reaching both current members and potential newcomers where they are most active.

The committee should also aspire to streamline the event information collection process, making it more efficient and organized. By implementing user-friendly tools and standardized procedures, we aim to simplify the event planning and promotion process, reducing the risk of errors and enhancing the overall event experience for our congregation.

Efficiency is critical, and we recognize the need for a more efficient image-creation process. By investing in better software and design tools, we can produce high-quality visuals, graphics, and multimedia content that resonate with our audience and effectively communicate our messages.

Lastly, the committee should better integrate our communication efforts with Constant Contact. Leveraging this platform more effectively will help us reach out to our congregation more personalized and engagingly. This includes refining our email campaigns, automating reminders, and utilizing data and analytics to tailor our content for maximum impact.

As we embark on this journey toward our future goals, we do so with a commitment to improving our communication, engaging with our community, and ensuring that our church remains an inclusive, informed, and vibrant place of worship and connection for all.

Budget and Resource Allocation

The Communication Committee's budget summary for the year is as follows, based on the provided data:

- **Newsletter:** The budget for the newsletter is \$600, which is in line with the allocated budget.
- **Software Tools:** The budget for software tools was initially set at \$50, which aligns with the allocated budget.
- **Traditional Media:** The budget for traditional media was \$1,200, but the committee has spent only \$556 so far. This underspending of \$644 will mostly be spent on Christmas advertising.
- **Total Communications Budget:** The total allocated budget for communications was \$1,250. However, the committee spent only \$807, which aligns with the allocated budget and will be entirely spent by the year's end.

CALL COMMITTEE REPORT

The Call Committee would like to take this opportunity to update you on where we are in the call process. The Ministry Site Profile (the document that describes our community and congregation) for Peace was submitted in October 2022. We spent the month of November developing interview questions for pastoral candidates. In December, we held two mock interviews with a pastor that helps call committees throughout our synod prepare to receive names of actual candidates.

We received information on two candidates in the early spring and held initial interviews with both. The committee unanimously agreed that one candidate was not a good fit for Peace but that the other held great potential to be our next pastor. A site visit was scheduled to allow the candidate to become familiar with our area and provide for an extended interview, but given the obligations of Lent and Easter, this visit did not take place until late April.

After this visit the members of the committee again unanimously agreed to put this person forward for consideration of the call. This was communicated to the candidate, and they entered a period of discernment. We held a follow-up meeting with the candidate to allow us the opportunity to answer additional questions they might have that could assist in the discernment process. Ultimately the candidate withdrew from the process. Below is the letter that was sent to the committee communicating this (the only thing that has been removed is the name of the candidate at the end):

"Dear Call Committee of Peace Lutheran,

With peace and clarity, I am withdrawing my name from your call process. This has been a difficult decision, come with much prayer and reflection, talking with mentors and colleagues.

It seems the Holy Spirit has not called me to you.

Your congregation deserves someone who is excited to accompany you into God's "next" for you. I believe God is preparing that person for you. I so wanted it to be me, and yet, even as I write to you, I feel release, not grief. I am truly sorry that you are not where I am being called. You have many gifts and ways to use them in your community and I am certain that God has for you a pastor who will be excited to walk with you as you grow in new pathways.

May Holy Spirit bring your pastor to you quickly. May the ministry be fruitful and filled with joy and learning, blessings, and fellowship, as you become who you are next called to be."

It was not until September 27th that we received the name of another candidate. An initial interview was held on October 5th and the Call Committee unanimously recommended that we bring the candidate and their spouse into town for a site visit. The site visit and extended interview were conducted October 21-23. The Call Committee met again on October 24th and unanimously agreed to put forth this individual as the sole candidate to be the next pastor. This was communicated to the candidate, but they had visits with two other congregations scheduled in the next 10 days so requested to wait to make a decision until those visits were completed.
